
500 acres out of the SE corner and 914 acres along the south border. 1 Jesse D. and Mary Boring bought 481 acres from the NE corner.² In 1881 Cornelius Davis bought 1856 acres along the western and northern border of the league. This left 618 acres in the center of the league fronting the Brazos River for the Phelps homestead.

Orlando C. Phelps and his family remained upon the homestead for several more years. The 1880 Federal Census lists:

The 1880 Census also lists Almira L. Phelps in New Orleans as a widower aged 58 with her children Henry 38, Orlander H. 32, Amoret 24, and Pike 14. The exact date that the family moved from the plantation has not been determined but early in the 1890's Orlando and his wife were living in Houston, Texas. Rosetta A. Phelps moved to her daughter's home in New

Orleans and died there March 1887. Orlando C. Phelps passed away in August 1897 in Houston, Texas.



After the turn of the century in 1905 Almira L. Phelps sold the 618 acre homestead to Harris Masterson.⁴ Preston Leigh bought 460 acres which included the homestead from Harris Masterson the next year. Lula Leigh his daughter-in-law would later gain control of the property and her descendants continue to own many of the tracts around the homestead. The Afro-American farming community of Green Hill grew up in the area and the Green Hill Cemetery

was started near the 1936 Historical Marker for James A. E. Phelps. In 1936 the community had a church and school, but by 1988 only the church remained.⁵

In 1930 two local historians James A. Creighton and Clarence R. Wharton visited Orozimbo together. The photographs they took show the deterioration due to several hurricanes that hit the area in the early part of the twentieth century.




Photo Santa Anna Oak 1930




Photo Orozimbo 1930 with Santa Anna Oak⁷



