
Shadrack Rowe Plantation Brazosport Archaeological Society

Shadrack Rowe and his wife Sarah F. Trippe Rowe brought a large family from Mississippi to settle in Texas in ~1848-1849. Shadrack contracted to buy 715 acres out the west end of the Thomas B. Bell League from Willis C. Bell in the spring of 1849. During the next decade Shadrack Rowe doubled his land purchases from the Bell family and built a cotton and sugar plantation. Using slave labor during the mid to late 1850's Rowe was a consistent producer of sugar using horse power and by 1859 Rowe converted his sugar mill to steam power. After the Civil War the plantation was sold to two brothers, James C. and Charles P. McNeill and the Rowe family moved to the Brenham area in Washington County, Texas. James Calvin and Charles Philip McNeill were part of the Levi Jordan-James C. McNeill family that had moved to Brazoria County about the same time as the Rowe family. James C. McNeill and his wife Sarah Emma Reese McNeill lived on the plantation after their marriage in 1875 while Charles P. McNeill and his wife Ella Hinkle McNeill settled at Hinkle's Ferry on the San Bernard River. James C. McNeill turned his half ownership over to his wife in 1881. At the end of the same year the two brothers decided to partition the property they held together. As part of this partition the McNeill Plantation became the property of Charles P. McNeill. The McNeill family held ownership of the plantation for all of the 1900's. The Trust for Public Land was given the greater part of the acreage in 2000 by the Minnie Reese McNeill Estate. Robert Andrew McNeill and his wife now own a tract of land south of FM 2611 on which the ruins of the sugar mill are located. It is presumed that the greater part of the old plantation improvements would also be located near by although the exact locations are not known at this time.

Shadrack Manly Rowe and Sarah F. Trippe Rowe were married in Alabama in 1824 and their first three children were born there (See Appendix A). According to the birth places of their children by 1835 they had moved to Mississippi. 1848-1849 Shadrack Rowe brought his large family from Mississippi to Texas and settled in the western part of the Thomas B. Bell League west of the San Bernard River in Brazoria County. Shadrack Rowe entered a contract with Willis C. Bell to purchase 715 acres in the northwest corner of the Bell League in February 1849. Willis C. Bell had just recently received the tract of land from his father's estate. 2

The 1850 Federal Census lists the Shadrack Rowe family:

Shadrack Rowe had 30 slaves on his plantation and had evidently begun to work the property as a cotton plantation as by the 1850 Agricultural Census he had 170 acres improved and his plantation valued at \$5000 with \$1100 worth of farm machinery. The livestock on the property consisted of 4 horses, 4 mules, 30 milch cows, 4 working oxen, 170 head of cattle, and 150 swine. In 1849 he had produced 1000 bushels of Indian corn, 50 bushels of Irish potatoes, 600 bushels of sweet potatoes, 300 pounds of butter, 6 tons of hay, and 24 bales of cotton.

During the 1850's several of the Rowe children were married. Three of the sons, Benjamin (Frank), Napolean (Pobe), and Shadrack (Manly), and one daughter Rozella (Emma), attended Baylor at Independence.³

Shadrack Rowe started to cultivate sugar cane in the middle 1850's using horse power in his sugar mill:



In 1859 P. A. Champomier lists Shadrack Rowe as having converted to steam power but does not list his production for that year.⁵ In the 1860 Agricultural Census which would have been the production for 1859 Rowe listed 74 hogsheads and 8000 gallons of molasses.

In March 1858 Shadrack Rowe received clear title to the 715 acres he had originally purchased from Willis C. Bell and in September 1858 Shadrack Rowe bought Tract 2 of the Thomas B. Bell League from Christopher C. Bell which made him the owner of ~1430 acres on the west end of the league.⁶ He borrowed an additional \$10,800 from Levi Jordan, a local planter who lived just north of him that same year.⁷ These could have been the funds necessary to convert his sugar mill to steam power. By November 1860 he was able to pay his debt to Christopher C. Bell for the additional 715 acres by borrowing more money from Levi Jordan.⁸ Levi Jordan held the mortgages on all of Rowe's land and the majority of his slaves. The Jordan-McNeill and Rowe families were not only bound by a business relationship but the two families were often together in a social atmosphere with members from both families often visiting each other.

Shadrack Rowe had built his plantation along a slough that fed into what is now called Cocklebur Slough very near the southern boarder of Tract 1. The road from Hinkle's Ferry to Cedar Lake ran along the ridge of the old slough and lay just south of his improvements. By 1860 he had 300 improved acres owned another 1115 acres and valued his plantation at \$25000 with \$8000 worth of farm equipment (Sugar Mill, Cotton Gin, Cotton Compress, and Saw Mill) on the property. Livestock on the plantation consisted of 10 horses, 12 mules, 25 milch cows, 16 working oxen, 600 head of cattle, and 100 swine. In addition to the 74 hgshds sugar and 8000

gallons of molasses, Rowe produced 3000 bushels Indian corn, 30 bushels Irish potatoes, 600 bushels sweet potatoes, 400 pounds of butter, 10 tons of hay, and 62 bales of cotton in 1859. The 1860 Slave Census lists 39 slaves with 7 slave dwellings. The 1860 Federal Census lists the Rowe family:

By 1860 Shadrack Rowe's older brother William Rowe⁹ who had moved to Texas was living in close proximity of Shadrack:

William Rowe	75M (Planter)	North Carolina

There is very little record of the Rowe family during the Civil War. Pobe (Napolean B.) and Frank (Benjamin F.) Rowe joined the Confederate companies guarding the local gulf coast

and managed to obtain leave at opportune times to be married in 1862. Manly (Shadrack M.) Rowe was also stationed locally.¹¹

After the Civil War Shadrack Rowe's debts to Levi Jordan remained but being unable to secure a stable labor force for the plantation he and his wife sold out their interests to James C. and Charles P. McNeill in April 1866. For \$17,000 Rowe deeded over ~1430 acres less 2 acres in the northwest corner of his tract which "embrace the church & graveyard known as Cedar Lake Church¹²". They also conveyed all the improvements on the plantation including "Sugar House, Gin House, Cotton Press, Residence, & all out Houses, Saw Mill & c. & c."13 All the livestock on the plantation, amounting to 800 head of cattle, was sold to Levi Jordan for \$3000.14 At the end of 1866 the Rowe family moved to the Brenham area in Washington County, Texas.¹⁵ Frank Rowe and his wife Sarah Mims Rowe remained in Brazoria County and bought property north of the old plantation in the Mims League while many of the other married children left the county and scattered through Texas.

Calvin (James C.) McNeill went to the Wharton area to secure freedmen to perform the labor on the old Rowe Plantation for 1867. According to Calvin's sister Sallie McNeill "nearly every building on the place will have to be rebuilt. I wish the Rowe's could have kept their own place." ¹⁶ Calvin moved to the new McNeill Plantation as his brother Charles went to school in North Carolina.¹⁷

Charles P. McNeill married Ella Byrne Hinkle (daughter of William B. Hinkle) in October 1874 and James C. McNeill married Sarah Emma Reese in January 1875. Calvin and Sarah McNeill resided at the old Rowe Plantation then known as the McNeill Plantation. Charles and Ella McNeill made the old Hinkle home on the San Bernard River their home and according to family recollection built a new two story wood frame house on the location ~1877.



The Charles P. McNeill Home Facing the Prairie Courtesy of the Brazoria Historical Museum Early in 1880 the plantation home of Calvin McNeill burned down. At this time a large part of the McNeill family had been living with him after they had lost possession of the Levi Jordan Plantation. The whole family then moved to stay at the home of Charles P. McNeill.¹⁸


Calvin McNeill transferred ownership of his half interest in the McNeill Plantation to his wife Sarah in September 1881.¹⁹ By the end of the year Calvin and Sarah McNeill had bought the Mims Plantation north of Hinkle's Ferry on the San Bernard River. Calvin and Charles

decided to partition all the property that was being held by the two families. Charles P. McNeill received the McNeill Plantation (Rowe Plantation) as part of this partition.²⁰

The 1880 Federal Census lists the C. P. McNeill household and Charles P. McNeill's occupation as a farmer producing sugar giving an indication that the sugar mill on the plantation was still operational:

Sarah Jordan (grandmother), Charlie and Calvin Martin (his young nephews) were also living in a dwelling next to Charles P. McNeill. Several domestic servants were also quartered in the vicinity.

The plantation eventually fell into ruin and according to Abner Strobel in 1926 "they [Charles & Calvin McNeill] developed it into a good sugar plantation and operated it for many years until it ceased to be profitable...It is, however, a wreck and mostly grown up in timber, brush, etc..."²¹

In June 1919 Charles P. McNeill sold 230 acres out of the plantation to his son Andrew Byrne McNeill.²² After the death of Andrew B. McNeill his wife Minnie Reese McNeill gave most of this tract to her son Andrew B. McNeill Jr.²³ The Minnie Reese McNeill Estate after her

death put the bulk of the old plantation lands in a trust for the public in 2000.²⁴ These tracts are now managed by the U. S. Fish and Wildlife Department. Her grandson Robert Andrew McNeill and his wife now own the greater part of the old 230 acre tract south of FM 2611. Ruins of the sugar mill are located on this tract and it presumed that the greater part of the old plantation improvements would also be located near by although the exact locations are not known at this time. The lands managed by the U. S. Fish and Wildlife Department contain old home sites of tenant farmers. The old Cedar Lake Cemetery is still designated as a cemetery in the northwest corner of the Thomas B. Bell League.
