

“De Bouie Non”-David H. Milburn Plantation
Brazosport Archeological Society

David H. Milburn came to Texas from Tennessee in 1823. He and his business partner Thomas Davis received title to one league of land on the west bank of the Brazos River in Austin County on July 29, 1824. In Brazoria County David H. Milburn married Elizabeth Bailey Pharr in 1826, the daughter of Britton and Edith Smith Bailey. He purchased a large portion of the Samuel Carter League and settled on the east bank of the Brazos River opposite the town of East Columbia. In East Columbia Milburn was in the mercantile business with Ammon Underwood while he lived on his ~ 1000 acre cotton plantation in the NW corner of the Carter League until his death in 1840. The descendants of David H. Milburn continued to own portions of the property even through the 1990’s. The plantation was leased or rented while most being owners while living elsewhere beginning in the 1850’s.

David H. Milburn was born March 15, 1790 in Virginia. In ~1823 he came to Texas and received title to one league of land on the west bank of the Brazos River in Austin County on July 29, 1824 with his business partner Thomas Davis.¹

In October of 1826 David H. Milburn married Elizabeth “Betsy” Bailey Pharr, the daughter of Britton and Edith Smith Bailey. Elizabeth Bailey Pharr was only nineteen years old and had a young son Augustus Pharr, Jr. by a previous marriage. This was actually a double marriage ceremony in which her sister, Mary Augusta Bailey, often rumored by the family to have caught the eye of Stephen F. Austin, married Joseph Henry Polly the same day.² The Milburn’s would have five children together. (See Appendix B)

During the next few years Benjamin Fowler sold David H. Milburn the greater portion of the Samuel Carter League which lay directly opposite the town of Marion or East Columbia on the east side of the Brazos River.³ Benjamin Fowler died January 9, 1834 at age 74 at the home of David H. Milburn.⁴

In June 1832 David H. Milburn was a member of the Brazoria militia which attacked the Mexican fort at Velasco. He is listed in Henry Smith's Division 2.⁵ On July 2, 1832 Milburn was in command of a small detachment of men from Brazoria sent to assist Lieutenant George B. McKinstry commanding at the mouth of the Brazos River in removing all their provisions and ammunition from their camp to the fort for safe keeping.⁶

In December 1836 Ammon Underwood, David H. Milburn, and John P. Coles went into the mercantile business in Marion or East Columbia, Coles being a silent partner. According to Ammon Underwood neither Milburn nor Coles had any experience and he would actually run the day to day operations in the business.⁷

Dry Goods, Groceries & c.

MILBURN & UNDERWOOD have just received and have on hand, a general assortment of Groceries: Wines and Liquors; Porter, Ale, and Cider; Hardware: Dry goods; Boots, Shoes and Clothing. All of which they offer for sale at the most reasonable terms—Marion-March 13, 1837⁸

Milburn and Underwood would remain in business together until the death Milburn in early 1838. February 25, 1838 David H. Milburn made out his will:

Know all men by these present that I David H. Milburn of the County of Brazoria and Republic of Texas. Whilst sane and in my proper senses, do make and publish this my last Will and Testament. And first I direct that my body be decently interred on my own land and burying ground and that my funeral be conducted in a manner corresponding with my Estate and situation in life. And as to such worldly estate as it has pleased God to entrust to me with: I dispose of the same as follows: First I direct that all my debts and funeral expenses be paid as soon after my decease as possible out of the first moneys that shall come into the hands of my wife as executrix from any portion of my estate real or personal; Also I direct that a fair valuation or appraisement be made by three judicious neighbors of all my said estate including my household furniture and after being signed with their names that a copy of the same be given to each of my friends whom I shall designate to assist my Good and lawful wife Elizabeth Milburn as sole executrix of my Estate [De Bouie Non]. Also I do direct that the whole of my estate that I bequeath unto my children as the case may be shall be and remain absolute property of my dear beloved wife, if she be living at the time of my decease but if she should not survive me then the same shall be given to my children, share and share alike and to be apportioned by three impartial neighbors to be chosen by my children for that purpose. But should my wife survive me my will is, and I do appoint my dear said wife to have the tuition and Guardianship of them during their minority so long as she continue sole [single] and in the case of her death or marriage during the minority of such my children as are hereby described. Viz. Benjamin F., William, Mary Elizabeth, and Bethia Harriet Milburn and those who may be born hereafter of my name as my heirs shall receive the same education and quantum of my real and personal estate as the aforementioned. And it is my request that my children be raised in an

orderly way-and should it take half my estate I do hereby instruct my Wife and assistant Executors to have given my said children a liberal education also Augustus Fair [Pharr], a son of my wife by her guardian husband David Fair [Pharr], and for him to receive the same Education as any of my own children to be paid out of my estate without any charge to him. Also so much money to be made out of my Estate as will pay all expenses on a certain half of a League and half Labor of land not as yet surveyed I have attained for him under the Constitution of the Colonization laws and as soon as he becomes lawful age the same to belong to him in fee simple title to locate or dispose at his own option. And should my wife Elizabeth Milburn as aforementioned marry after my decease then she is to share a child's part. But should any of my children arrive at lawful age and make application for his or her quatum of my estate then my aforesaid neighbors shall arbitrate and hand in their award. And the same shall receive his or her partition. But should the arbitrators not agree then they shall choose an umpire and decision of whom shall be valid!!! And should any of my children have died as the Heads of Families and have received their quatum of my personal and real estate according to the partition or distribution shall not receive any more. But as aforesaid, my wife if married to share and share alike, as my children and of my personal and real estate thus bequeathed to my wife to be in lieu of her dower; at Common Law if she shall so elect and I do hereby make and ordain my esteemed neighbors William Aldridge⁹, A. Underwood, J. Coles, and Charles D. Sayre assistant executors to my wife of this my last Will and Testament. In witness whereof I, David H. Milburn the Testor, have to this my will written on one sheet of paper set my hand and seal this twenty fifth day of February in the Year of our Lord One Thousand Eight Hundred and Thirty Eight. D. H. Milburn¹⁰

At the time of his death March 30, 1840¹¹, David H. Milburn owned fifty per cent of the mercantile business with Ammon Underwood amounting to over \$16,000. His total estate was valued in April 1840 to over \$40,000. His plantation was valued at \$10,000 with slaves listed:

In addition to the mercantile business David H. Milburn also operated a ferry business given the natural location of his property directly across from East Columbia.

To Owners of Slaves

Notice is hereby given to all persons whom it may concern that no Negro slave will be permitted to cross the Ferry at Columbia, without an order, pass, or other writing to show that he is on business for his master, mistress, or overseer.

In the years preceding his death David H. Milburn had sold most of his holdings in the Samuel Carter League reserving a little over 1000 acres in the northwest corner along the Brazos River for his plantation.¹⁴ After his death his business partner Ammon Underwood was quick to announce the breakup of their old firm and attempt to settle the affairs of their business though this would take several years:

Dissolution of Copartnership
THE Copartnersip heretofore existing
under the name and style of
MILBURN & UNDERWOOD
was dissolved on the 31st of March last, by
the death of the former (Mr. David H. Mil-
burn.) All persons having claims against said
firm are requested to prepare the same for
payment and those indebted to said firm
are called upon to make immediate payment
as suit will be instituted against all who are
indebted to them next term of District Court,
who fail to attend to the above notice.
The entire stock of Merchandise now on
hand is offered for sale at very reduced prices
for Cash to close the business of the firm.
A.UNDERWOOD
Surviving Partner of said firm.
Columbia, April 17th, 1840¹⁵

Elizabeth Milburn became the executrix of her husband's estate with Ammon Underwood as the assistant executor and lived on the property before her marriage to Claiborne Rector, August 10, 1841. Claiborne Rector had come to Texas in 1831 with his father and mother, Morgan and Amelia Rector along with a sister and six brothers from Alabama. March 1, 1836 he enlisted in William H. Patton's company, 2nd Regiment 4th Infantry of Sam Houston's army and fought at the Battle of San Jacinto. Claiborne and Elizabeth would have two daughters together before her death, May 22, 1847. By 1850 Claiborne Rector had moved to Bexar County with his two young daughters.

Claiborne Rector was released from the being the administrator of the David H. Milburn estate and his wife's estate in 1847. Charles D. Sayre, who lived just north of the Milburn Plantation petitioned the probate court and became the guardian for all of the minor children of David H. Milburn. Being over seventeen years of age both Benjamin and William chose Sayre to be their guardian. Charles D. and Catherine Sayre took Mary and Frances Milburn to San Antonio to enter school under the Reverend John McCullough, a Presbyterian missionary and teacher, who had married the Sayre's adopted daughter Lorena W. Sayre. Harriet Milburn was placed in school at Ruterville College.¹⁶ After the death of their daughter the Sayre's moved back to their plantation on the Brazos River. Benjamin F. Milburn became the guardian of his minor brother and sisters in 1849.¹⁷

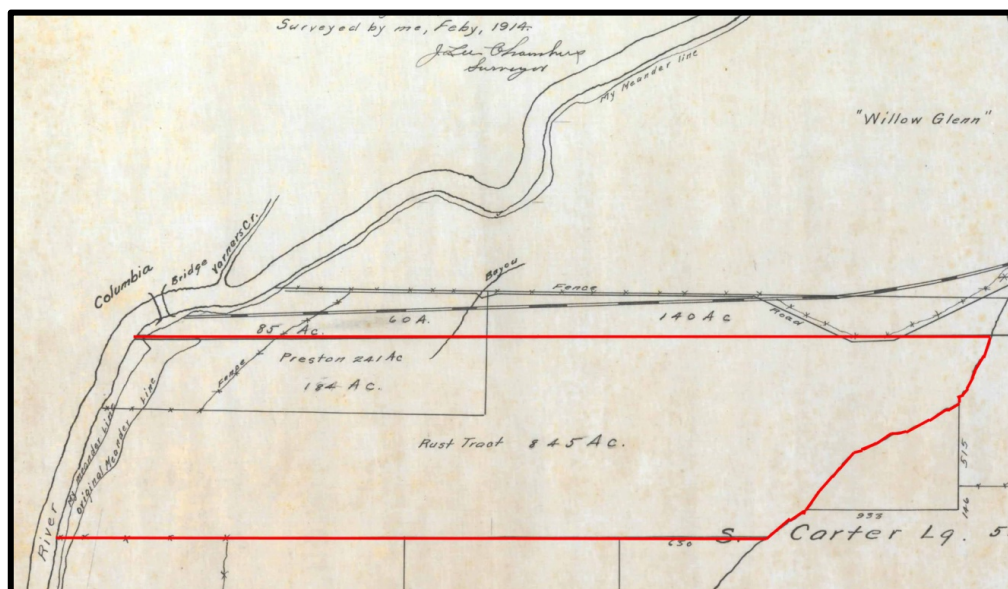

By 1852 Benjamin F. Milburn had married and moved with his brother to Wharton County. Their younger sister Frances Milburn was deceased. They sold their half interest in the Milburn place for \$4000 to the Lucy A. Milburn, wife of Benjamin as her separate property. Charles F. Patton was occupying and cultivating the plantation.¹⁸ September 1852 Benjamin F. and Lucy A. Milburn sold the same half share to Benjamin F. Atkins who had married Mary Elizabeth Milburn in 1851.¹⁹

Benjamin F. Patton may have rented the property for several years in the early 1850's as he had 15 slaves of his own before he moved to the Columbus R. Patton Plantation on Varner Creek in the later 1850's. The 1850 Census lists:

Benjamin and Mary Atkins would be owners in absentia living in Fort Bend County. In 1860 they sold the Milburn place to William Milburn for \$10,000.²⁰ In June 1860 William sold the property to Andrew Jackson Rust of Wharton County who had married Bethia Harriet "Halley" Milburn in 1854 for \$15,000.²¹

The heirs of Andrew Jackson and Halley Milburn Rust maintained ownership of the greater part of the plantation lands into the later part of the 1900's. Their daughter Lizzie Milburn Rust married Edwin Hawes. The Hawes estate may have leased the property for many years.

C. S. Preston bought 230 acres in the northwest corner on the Brazos River where the original homestead may have stood. This acreage had been originally partitioned to Hallie Rust Dunklin in 1880.²² P. S. Griffith bought the property in 1916.²³

The exact location of the home is unknown. The family burying ground is also a question mark. David H. Milburn requested that he be buried in his family burying ground which might also contain the grave of Benjamin Fowler who died in 1834 at Milburn's home.

On the bank of the Brazos River just across the line for the James B. Bailey League is the tombstone of Harriet Aldridge who died in 1841. William B. Aldridge, her husband, was a good friend of David H. Milburn and lived in East Columbia. Did he bury his wife in the Milburn cemetery? The accuracy of the surveys back in the early 1800's was not that great and it could easily be possible that Milburn thought this was part of his land. The current land owner does not know if there are other graves in the area or if it is possible the tombstone has been moved over the years.
